With over 705 donors who contributed \$793,773 during the 2022-2023 fiscal year, CKS is positioned for a bright future.

The past school year ushered in a new era of growth and innovation as CKS transitioned away from the Office of Catholic Schools to become an accredited independent Catholic school within the Archdiocese of Atlanta. Community support for the CKS Fund was instrumental in providing financial resources for the overall operating budget, which enabled us to expand and enhance the campus experience for faculty, staff, and students:

PARENT VOLUNTEER ASSOCIATION

The Parent Volunteer Association at Christ the King School is comprised of parents who are dedicated to enhancing our Community of Caring for students, families, and faculty and staff. Offering more than 40 different volunteer committees, it welcomes all parents to join in sharing their time and talent, enriching the CKS community through social, spiritual and fundraising events.

The PVA supports community outreach with our CKS Serves Committee. This committee facilitates service activities for students and their families. Our students have logged over 1,200 hours of service this year, and the entire student body participated in our Catholic Schools Week Day of Service, co-sponsored by CKS Serves and the school. Additional volunteer opportunities throughout the year included sandwich making for Morning Sandwich Ministry at the Shrine of the Immaculate Conception, collecting Winter Woollies for St. Vincent De Paul, filling over 400 Cross Catholic Outreach Christmas Boxes of Joy for children in need, wrapping Christmas Gifts for Foster Kids Matter, loading and transporting Christmas Gifts for Adopt-A-Family supporting Catholic Charities Christmas Connections, assembling cards, snack bags and blankets for refugee families through Catholic Charities, providing dinner to students through Agape Youth and Family Center, writing letters and cards to senior citizens, and packing 15,000 meals for Rise Against Hunger.

School-wide PVA events include the much-anticipated Halloween Festival, Jingle Jog, Mother-Son event, Daddy-Daughter dance, and Field Day. The Middle School co-chairs arrange special Middle School only events such as the Fall Picnic, Mother-Daughter Luncheon, Varsity Lunch, and 8th grade Graduation Reception. The 2023 Blue Jean Ball and Auction raised more funds than ever, \$288,000, and will provide funds for the CKS Community Garden.

An important focus for the PVA is to continually show our faculty and staff how much their hard work and commitment means to our community. The Teacher and Staff Appreciation Committee provides monthly lunches and goodies to the staff, the Birthday Recognition Committee treats the faculty to a lunch on their birthday, and the PVA Executive Committee organizes a Christmas and end-of-year collection that is given as a bonus to every school employee.

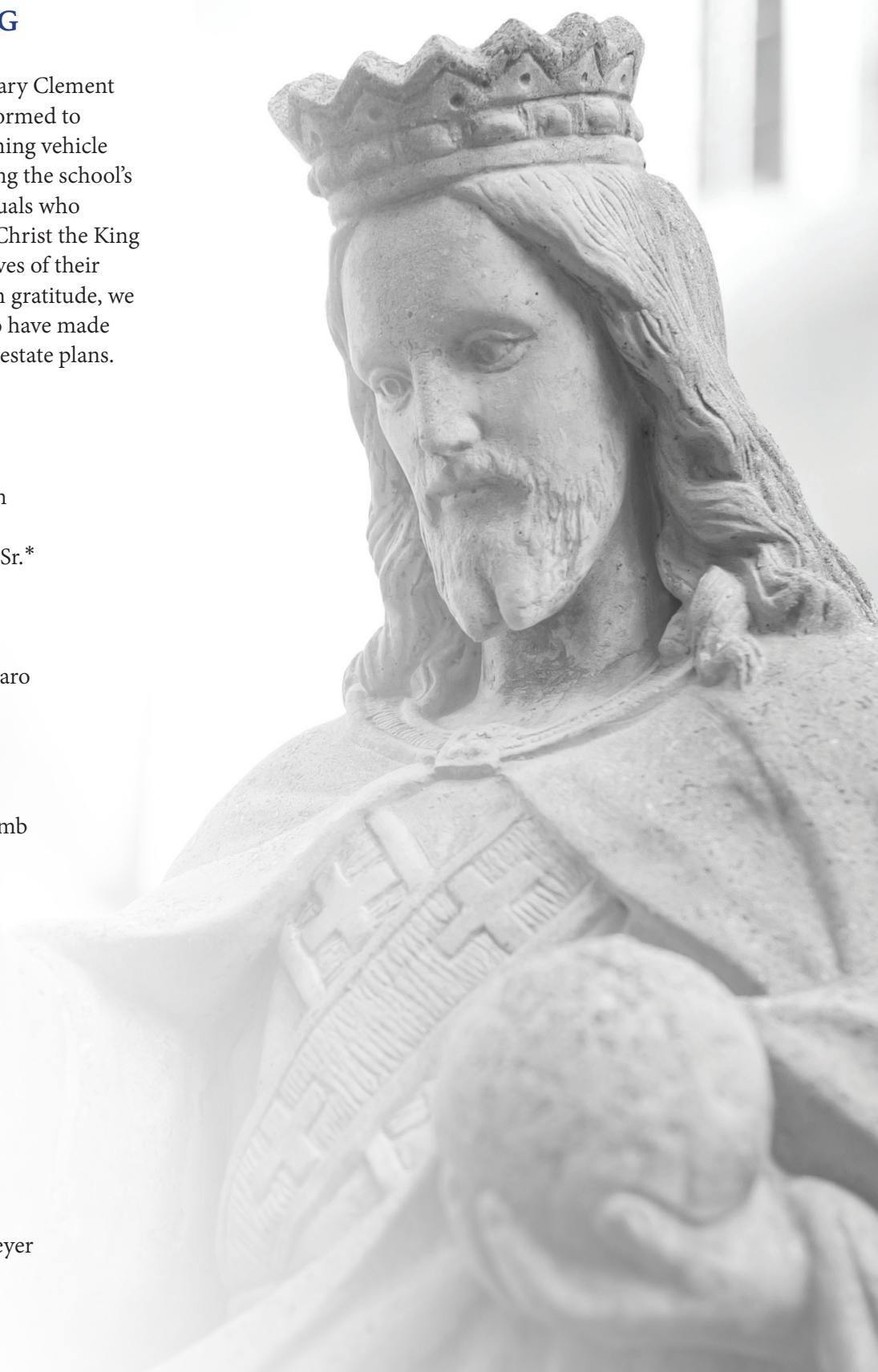
